Towns of Swift Creek Homeowners Association, Inc. reserves the right to require removal or repair of the modification at my own expense if: 1) The modification(s) is not constructed or installed as per the specifications submitted with this request, 2) The modification is not maintained in a safe condition, 3) The modification is not maintained in keeping with the surrounding structures and is not deemed satisfactory by the Board of Directors, or 4) Any construction or alteration is made prior to the approval of the Board of Directors.
5. Responsibility for the repair and maintenance of the modification(s) will pass on to any future owners of the home and lot for which this request is submitted.
6. Representatives of the Board of Directors and their agents are permitted to enter upon my property at any reasonable time for the purpose of inspecting the area for the proposed modification(s), the modification(s) in progress, or the completed modification(s), and that such entry does not constitute trespass.
